AFTER being a Queen Street landmark for 15 years, Wendy Slonin's Decor glassware shop at the corner of Queen Street and Moncur Street has closed down.

The new occupant will be antique dealer Michael Green, previously next door with his entrance actually inside Queens Court.

Wendy had been at Queens Court since it opened and she is not going out of business entirely. Her second shop at Mosman is still running.

Wendy told us she was leaving Queens Street with deep regret, but the business just could not carry the 50 per cent rent increase demanded when her lease came up for renewal.

"I have been amazed at the number of people who told me how sorry they were that I was going," she said. One woman was in tears. It's very sad.

BACK from Paris with a load of fine goods, Appley Hoare is looking for the right house to settle close to the Queen Street shop with her husband, Warwick, and daughter.

THE Lookout Theatre Club in the upstairs area of the Woollahra Hotel, mentioned in our previous column, is due to open on June 24.

First memberships have been accepted and organiser Andrea Baker hopes to hear from more locals who would like to join.

For legal reasons, the theatre must operate as a club with a membership fee of \$20 a year, or \$8 per performance if you take out membership at the door each time. Tickets

## Joint working party on Queen Street 2000

SEVERAL initiatives are in progress to get up and running Queen Street 2000, the Queen Street Association's scheme for upgrading Queen Street.

The scheme was described in the November Village Voice and an exhibition was held in Queens Court on December 12, the day of our Carol Concert

We were delighted that the Mayor of Woollahara, Alderman Hylda Rolfe, and a number of other aldermen and Council officials came to see our plans.

Their comments were encouraging, a good sign as the implementation of the scheme must be through a artnership between the Council and local interests.

The Mayor is a member of a joint working party set up for the scheme. The other Council representative is Alderman John Darling.

The Association's own representatives are Duane Norris (President), Ron Osborne (Treasurer) Robin Brampton (Secretary), Cynthia Gregory-

Roberts (Director) and John Haymes (Director).

Naturally, financial considerations will loom large in any discussions on the scheme.

So, together with the Association, Council officers are preparing indicatives costings, estimates for the working party to have before it when it meets for the first time.

In another move, the Association has applied to the Australia Council for a townscape improvement grant to provide funds for the detailed planning.

We were grateful that the Council supported this application though it had to be made clear that this did not indicate the Council's early approval of the scheme or any aspect of it.

Apparently, the Australia Council liked the way our application was presented and we hope to know the result this month — possibly by the Annual Meeting on May 15.



Whatever its general architectural merits, this is undoubtedly the Queen Street building most at odds in design with its neighbours in a boulevard where traditional styles so harmoniously predominate. The premises are the home of the National Council of Jewish Women who have recently remodelled the frontage to provide two large shops. They are now looking for tenants. Although the Queens Street Association was given no opportunity to comment on the change, we feel most people would take the view that the nothing is lost by bringing a little commercial liveliness to the front of the building, particularly if the shops can be of the king that serve day-to-day local needs, such as a fish shop or small supermarket, and not become yet another real estate agency.

# Restoration work starts again at Waimea House

IT is now more than two years since restoration work began on Waimea House in Waimea Avenue, the regency style residence almost destroyed by the Royal Blind Society in 1973.

In March the Queen Street Association wrote to Dr Bill Kelly of Parks Development which owns the building, expressing concern at the slow progress.

The building company which started the restoration is no longer involved, and a new builder has been engaged.

Although he has not replied to our letter Dr and Mrs Kelly have told a member of our committee that work has started again.

This is confirmed by activity on the roof where waterproof membrane has been placed, presumably in preparation for tiling.

The Kellys also told our committee member that the work will definitely by finished in time to integrate with the Association's Queen Street 2000 scheme.

Let's hope so

# Gutted church building not to be demolished

MORE than a year after fire tted the former Congregational Church in Jersey Road, the Uniting Church is still deciding its future.

However, Carole Baker, a property consultant engaged by the Church, has given an assurance that the building will not be demolished.

"Investigations are being made about future options and costs," she says in a letter to local residents.

"The Eastside Parish is conscious of its obligations to the heritage buildings it owns and is considering the best ways to ensure their upgrading and preservation."

However, the Eastside Parish has apparently decided to demolish the church hall in Jersey Road, at the present being used as a child care centre.

It proposes to develop the site with seven town houses, designed by architect Alec Tzanes.

Carole Baker says that members of the Heritage Council who inspected all the Eastside Parish properties expressed the opinion that the parish hall building did not merit any preservation order.

So there did not appear to be any reason why it could not be demolished.

Apparently there is no intention to include in the demolition the very pleasant single story manse building on the opposite corner of Jersey Road from the church which is used as a day centre for the frail aged.

#### PRESIDENT'S REPORT

AS the Association enters a new decade, I am happy to report that the past 12 months have been rewarding and productive.

After almost 20 years of active service, the Association is alive and well and, entering into its third decade, has set itself a very busy agenda.

That is not to say that this past year has been quiet. On the contrary, the Association presented at Christmas a detailed submission of plans for the beautification and improvement of the Queen Street streetscape.

The project, named Queen Street 2000, was put forward by the committee to give ideas and impetus to the general improvement of amenities, traffic, parking and appearance of the area.

The plans were produced some 12 months after the original idea was mooted and were prepared by the local firm of Duane Norris Garden Designers.

It is the single most exciting idea to come forward yet from the Association and it will take tremendous commitment from everybody involved to see it through to completion.

#### Music Hall

As well as Queen Street 2000, the Association organised, together with the Senior Citizens' Association, the hugely successful Queen Street Music Hall, held on two consecutive nights at Gaden Reserve.

The success of this night was due largely to the efforts of our Secretary, Mr Robin Brampton, and Mr Cec Monkhouse.

It was an evening not to be missed and for the 200 or more people who attended it was a wonderful nostalgic evening.

Less successful was our Market Day in September. It was promoted as a giant garage sale where locals could sell their unwanted goods.

The Association managed to sell all 30 stalls available but the public failed

to support the idea. As a result, it sounded the death knell for any further Market Days.

The final social event of the year was the annual Christmas Carol Concert. Held at Queens Court with the Taverner Consort leading the vocals, it played to an absolutely packed house.

Well over 100 people attended together with the Mayor, Alderman Hylda Rolfe, and Clover Moore, our local MP.

Thank you all for making it a great success.

#### Local Watchdog

The Association has continued its role as a watchdog on local issues and has been involved in a number of important matters over the past year.

Firstly, it joined with local residents to vent its disapproval over Woollahra Council's intention to change part of the Code 24 to make way for parking bays in Peaker Lane.

Strong objections were submitted to Council and the action was finally dropped.

The Association has also maintained its vigilance on developments at Waimea House and the ongoing disputes between the Phoenix Hotel and Woollahra Municipal Council.

As I stated earlier, the plans for Queen Street 2000 present the most ambitious project that the Association has put forward in its existence.

The plans have been favourably viewed by Woollahra Municipal Council following a preview prior to Christmas.

It is envisaged that the project will be a joint venture between Council and the Association with community help and involvement. A working party has been formed with members of the Council and the Association.

An application has been made to the Australia Council for a grant to help pay for the production of the final design details, the working drawings and the specifications.

Currently, the Council and the Association are doing a preliminary costing on the feasibility of the project, the results of which should be known by the time of the Annual Meeting.

Once this has been done, the concept plans will go on public viewing for four weeks. It is hoped that the Westpad Bank in Queen Street will allow plans to be displayed there.

Currently, the NSW Department of Planning is looking favourably on such street projects and has sent one of its staff members to view 70 or so such projects that have taken place in Canada.

A questionnaire is being prepared for local residents who view the exhibit and wish to make comment. The Association would appreciate hearing the comments of residents on the merits of such a project.

Firm dates for the display of the plans will be announced.

#### Coming Events


The most important meeting of the year for the Association is the Annual Meeting, being held on May 15.




